3. Composition/information on ingredients

4. First aid measures

7. Handling and storage

- Storage** : Store in accordance with local regulations. Store in sealed container in cool (2-8°C), dry location. Store in original container protected from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see section 10) and food and drink. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. - Chemical stability** : The product is stable.
- Conditions to avoid** : Azides are reported to react with lead and copper in plumbing to form compounds that may become explosive. When disposing of solutions containing sodium azide, flush with copious amounts of water to minimize the build up of metal azide compounds.
- Materials to avoid** : Azide reacts with many heavy metals such as lead, copper, mercury, silver, and gold to form explosive compounds. Copper and lead azides are more sensitive than nitroglycerine. Azide reacts with metal halides incompatible with chromyl chloride, hydrazine, bromine, carbon disulfide, dimethyl sulfate, dibromomalonitrile.

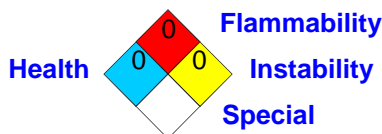
